## REGULATION

on carrying out the summer Training camps in rythmic Czech Republic, Hradec Kralove

### 1. General provisions

Rhythmic gymnastics camp z.s. is organizing summer sports camp (hereinafter referred to as only "TC"), in cooperation with autonomous non-profit organization Irina Viner's International sports academy, which will be carrying out trainings for following purposes:

- 1. Improving sport and physical performance of attendants;
- 2. Finding artistic potential of attendants;
- 3. Revelation of talented and perspective gymnasts;
- **4.** Reinforcement of sports relationships between sports organizations Russian federation and European Union.

## 3. TC participants

To our camp we invite female gymnasts born in the years of 2001 to 2012 without any health conditions that could cause problems and medical contradictions to modern gymnastics.

#### 4. Conditions for admission to TC

Attendants are required to have on them:

- identity card/document (original and copy);
- medical admission from the doctor that the child is allowed to be involved in rhythmic gymnastics;
  - insurance policy against accident/injury/death
- document certifying the identity of the person in charge (original and copy) for the participant or group of participants.
